Operator Report: 1) Ottawa Booster pumped 4.5 M in May and the well pumped 1.1M in May. 2.) We had 1 leak repair on Indiana Rd, North of Jackson Rd from the County tree clearing project they took out ½ mile of trees. 3.) New Meter Installed on 309 Ellis Terr. 4.) We have 17 meters left to change out. 5.) The sprayer for the tractor is ready. 6.) A couple people on 2400rd are interested in doing a line extension, still not for sure if they want to go through with it or not. 7.) Took 8 samples from around the district from people's houses to send to a lab in Minnesota that we buy our chemical from to test the water to see if we need to be improving anything on our end. 8.) We are going to have to start going house to house to see If we can get the rest of the lead and copper forms completed for EPA/KDHE, board members said they can help in the evenings if needed. 9.) Sampling stations, Phil asked if they would be interested in getting sampling stations for around the district, so he doesn't have to go into people's houses anymore to collect them. KDHE has requirements on them, and Blake Jorgensen made a motion if we can keep the cost \$1,500 a piece or under for 10 total stations that would be approved Bob Ramshaw Seconded the motion, motion carried with a 5/0 vote.

Office Manager Report: 1) We had 83 delinquent accounts as of May 15th. Billed out \$993.27 in late fees. 2.) We have 1 CD Renewals coming up in June, were leaving at Patriots Bank since it is the CD for the Bond for the water tower. 3.) 2 cd's from last month went back into Patriots since they had the best rates at 5.10%. 4.)
