Misson systems updating radio systems we have a total of 7 that need replaced, going to get ahold of Lloyd Harold to see price per radio, and start to get them all changed out. 8.) Valve replaced Douglas & Kentucky Rd. it broke when the leak was getting fixed on Douglas.

Ellie will be printing the Annual Meeting notices and getting them ready to put in Januarys Bills. 3.)
